

The Growth of Krakow as a GBS Location


- Motorola Research and Development Center in Krakow in 1998
- Around 2017 Krakow was in the top-10 of the Tholons Top-100
- Today: ca. 130 service centres 100–120,000 people direct employed in service centres. This is ca. 30% of the working population!



Slower growth

- Slower growth, first attrition to lower cost countries
- For procedural roles, Krakow is expensive
- For higher value added roles, Krakow is competitive both in quality and price

Need

- university collaborations that surpass recruitment and focus on R&D
- investing in employees to pursue further qualifications



Example HSBC: Academic Partnerships

What we do:

- 1. recruitment: graduate programs, job fairs

Result

- 1. smoother, more effective and cheaper recruitment
- 2. personal development and growth (not only teaching, also MBA, PhD, etc.)
- 3. teamwork, networking for employees and students
- 4. common R&D via PhDs, researchers, teachers, etc.
